

- The University of Prince Edward Island Academic Integrity Committee, the Senate Committee for Excellence in Teaching and the Teaching and Learning Centre are collaborating to promote academic integrity with an emphasis on the ethical use of generative Artificial Intelligence in teaching and learning.
- The Department of Education and Early Years, Government of PEI, has developed Principle and Guidelines on the use of generative AI in education for the K-12 sector.
- PEI is part of the new Academic Integrity Retouver (AIR) which is a group of Academic Integrity enthusiasts from the Atlantic Provinces who are meeting periodically to discuss and promote academic integrity in the region.

- We had our first Academic Integrity Day October 31st organized by the « Service d'animation et de soutien à l'enseignement ». The main topic was artificial intelligence.
- The « Service d'animation et de soutien à l'enseignement » has been transformed into a « Centre d'excellence en pédagogie universitaire, créativité et engagement ».
 - We will see what happens with academic integrity with this new center.

Partnership on University Plagiarism (PUPP)

- 4,123 questionnaires administered to students.
- 1,076 questionnaires administered to professors
- 125 individual interviews were conducted with professors
- 103 focus groups were conducted with students for a total of 406 students
- 15 writing tasks have been completed by students
- 6 writing tasks have been completed by professors
